The firearm(s) listed above has been seized as safekeeping and is in the custody of the Sugar Land Police Department under Texas Code of Criminal Procedures 18.191. This document serves as a written notice for the procedure for the return of the firearm(s) listed above.

The Sugar Land Police Department will contact the court of jurisdiction to determine commitment or release. If the court orders release of the above person, the Sugar Land Police Department will, no later than the 30th day after court notification has been received, provide written notice that the firearm(s) be returned to the person if eligible. If the court orders commitment of the above person, the Sugar Land Police Department will, no later than the 30th day after court notification has been received, provide written notice to the person of the following:

1. The person is prohibited from owning, possessing, or purchasing a firearm under 18 United States Code Section 922 (g) (4);
2. May petition the court that entered the commitment order for relief from the firearms disability under Health & Safety Code Section 574.088
3. May dispose of the firearm in the manner provided:
 - a. Release the firearm to the person's eligible designee,
 - b. Provides a notarized statement releasing the firearm to the designee,
 - c. Provides an affidavit confirming that the designee:
 - i. Will not allow access to the firearm by above listed person
 - ii. Acknowledges the responsibility of the designee and no other person to verify whether the person has reestablished the person's eligibility to lawfully possess a firearm under 18 U.S.C. Section 922 (g) or:
 - d. If a firearm subject to disposition is wholly or partly owned by a person other than the person taken into custody, the Sugar Land Police Department shall release the firearm to the person claiming right to or interest in the firearm after:
 - i. The person provides an affidavit confirming they wholly or in part own the firearm; will not allow access to the firearm by the above listed person, and acknowledges the responsibility of the person and no other person to verify whether the person has reestablished the person's eligibility to lawfully possess a firearm under 18 U.S.C. Section 922 (g)
4. If the Sugar Land Police Department does not receive written request as stated above before the 121st day after the date of written notice was made, the firearm may be sold and the proceeds of the sale given to the person from whom the firearm was seized less costs of administering the sale.
